

### OER Liaison Newsletter – November 2021

### Greetings OER Liaisons!

It's hard to believe that Thanksgiving is right around the corner and the end of both the term – and 2021 – is rapidly approaching. As we continue to grapple with the challenges of the present, we are also looking forward to what the future has to offer. Most notably, how the dollars allocated to the system for ZTC degrees will be disbursed. You'll see more about this in the general portion of the newsletter. As those of you who reviewed and offered feedback on our OERI Textbook Affordability and Cost Transparency Proposal know, we have tried to provide ideas for how the funds might initially be allocated, with a specific emphasis on supporting colleges in implementing a no-cost mark on class schedules since the pathway to a ZTC degree consists of ZTC course sections.

An important note on OER development proposals: We are anticipating another funding round. Provided all necessary approvals are received, we will be publishing a Request for Proposals by the end of November with informational office hours to follow in early December.

## OER Liaison Activity Tracking – Reminder

Please review the Fall 2021 OER Liaison Expectations to familiarize yourself with the anticipated activities and remember to use the Fall 2021 OER Liaison Tracking Spreadsheet (tinyurl.com/OERL-2021F) to record your liaison activities throughout the term. Your entries in the tracking spreadsheet are used by your Regional Lead to confirm your participation and verify your eligibility for the OERL stipend at the end of the term. ## Annual OERL Survey – Due November 4

If you are a seasoned OER Liaison, you are aware of our annual survey that is intended to track the implementation of the legislatively required marking of nocost ("zero-textbook-cost" or ZTC) course sections. As we indicated in the October newsletter, this year's survey is slightly different from past years. The survey will solicit some of the usual information, but it will not request your total

count of ZTC sections (unless that information is readily available). Instead, we are requesting data on specific courses and additional general information regarding your local efforts to reduce textbook costs and ensure cost transparency. If you'd like to access the questions outside of the survey, we have made the Fall 2021 OERL Survey Questions available to you. We hope that this information will give us a better sense of OER course-level implementation, and its impact on students. Please complete the survey by 5:00 pm, Thursday, November 4, 2021. ## OERI Seeking Discipline Leads

The ASCCC OERI is recruiting faculty to support our OER advocacy efforts by serving as Discipline Leads during the 2021-2022 academic year. The specific tasks of each Discipline Lead will be determined by the status of the discipline. Each Discipline Lead will serve as a resource for their discipline colleagues and will typically host at least one virtual event each term. Discipline Leads receive a stipend of \$500 at the end of each term upon completion of their specified tasks. #### What is "Inclusive Access"?

Inclusive Access has taken off as a sales model that automatically adds the cost of digital textbooks into students' tuition and fees. While this model is intended to address some of the challenges with high textbook costs, it is also creating new challenges for students and faculty.

How exactly does Inclusive Access work? Does it really save students money? How "inclusive" is the Inclusive Access program? Straightforward answers to these simple questions aren't always easy to find.

<u>InclusiveAccess.org</u> is a one-stop-shop for information, tools, and other resources to help administrators, faculty, students, and policymakers make informed decisions about Inclusive Access and its implications for the campus community.

#### ASCCC OERI and "IDEA"

To support faculty as they implement a culturally responsive and anti-racist pedagogy, the OERI, in response to the ASCCC Resolution 09.05 adopted in Spring 2021 (<u>Developing an Anti-Racism, Diversity, Equity, and Inclusion Curriculum Audit Process</u>), has been tasked with the development of:

- an audit process and review framework to evaluate existing open educational resources to ensure that ASCCC OERI-supported open educational resources are equitable, inclusive, diverse, and antiracist; [and]
- a curriculum audit process and review framework to assess instructional materials for equity, inclusiveness, diversity, and antiracism and make the process and framework available for local consideration, modification, and implementation[.]

Your review and feedback of the developed resource is desired. <u>LibreTexts</u> is the largest, most comprehensive open educational project online hosting over 300,000 pages of openly licensed content that can easily be adopted or adapted as needed. In this webinar, we will provide an over of setting up and logging in to your LibreTexts account, navigating the platform, using your sandbox to edit OER, using the Remixer to create and tailor OER for your courses, using the LibreTexts one-stop bookshop to print OER at cost, and importing LibreTexts content into Canvas. While this session is intended to be a brief overview of the LibreTexts platform, you should gain a clearer understanding of how the site works and learn how using LibreTexts to transition from more traditional, and often costly, educational materials to OER is easier than you might think.
