If you are receiving this and you are no longer the OER Liaison for your college, [please let the OERI know](#). To ensure the college is aware of the OERI's work, the local senate president will receive these newsletters until a new OER Liaison is identified.

Each term we seek confirmation of who holds the OERL position from your local senate president. The spreadsheet indicates if your appointment has been communicated to the ASCCC Office. • Annual OERL Survey •

If you are a seasoned OER Liaison, you are aware of our annual survey that is intended to track the implementation of the legislatively required marking of no-cost ("zero-textbook-cost or ZTC) course sections. This year's survey is slightly different from past years. The survey will solicit some of the usual information, but it will not request your total count of ZTC sections (unless that information is readily available). Instead, we are requesting data on specific courses and additional general information regarding your local efforts to reduce textbook costs and ensure cost transparency. We hope that this information will give us a better sense of OER course-level implementation, and its impact on students. Please complete the survey by 5:00 pm, Thursday, November 4, 2021. • ASCCC Fall Plenary – November 4 - 6 •

At the upcoming ASCCC Fall Plenary, several resolutions regarding the use of the state's considerable investment in zero-textbook-cost degrees will be considered, as well as related resolutions focusing on cost-transparency and textbook affordability. We hope these resolutions – as well as the entire resolution packet – will spark useful local conversations. Stay tuned...

• ASCCC OERI and "IDEA" •

To support faculty as they implement a culturally responsive and anti-racist pedagogy, the OERI, in response to the ASCCC Resolution 09.05 adopted in Spring 2021 ([Developing an Anti-Racism, Diversity, Equity, and Inclusion Curriculum Audit Process](#)), has been tasked with the development of:

- an audit process and review framework to evaluate existing open educational resources to ensure that ASCCC OERI-supported open educational resources are equitable, inclusive, diverse, and anti-racist; [and]
- a curriculum audit process and review framework to assess instructional materials for equity, inclusiveness, diversity, and anti-racism and make the process and framework available for local consideration, modification, and implementation[.]

In the interest of addressing this resolution in a timely manner, a work group was formed in the summer of 2021 to develop a draft process that could inform new OER projects and, potentially, be piloted this term.

During the work group's first meeting it was acknowledged that the proposed audit would likely be one of many IDEA-related resources the ASCCC might pursue. Recommended companion resources would likely include an IDEA framework for discipline texts, syllabi, student projects and assignments, and teaching practices. Additionally, the framework will be dynamic and as such, an iterative process for review and improvement will also be developed.

Your review and feedback of the developed resource is desired. We anticipate gathering input various ways and look forward to hearing from you.
