• Fall 2022 ASCCC Open Educational Resources Liaison Survey – Due Monday, November 21, 2022 •

It's not too late to complete the ASCCC OER Liaison Survey. Because of recent state-level developments, we suspect that many of you will be happy to see that we are no longer asking for no-cost course section data. • New ASCCC OERI Accessibility Checklist •

To ensure that all projects supported by the [Open Educational Resources Initiative](#) (OERI) are accessible, the OERI requires authors to demonstrate their accessibility competence or complete related training. While many projects may need additional accessibility considerations, the [OERI Accessibility Checklist](#) is intended to delineate the baseline accessibility standards for all OERI developed resources. Please see the [OERI Accessibility Checklist Overview](#) for additional information. This checklist and associated resources are presently in draft form. We encourage you to review them and [provide the OERI with any questions or feedback](#). We hope these resources will be useful as you engage in OER development at the local level.

• ZTC Guidance and “Phase 1” Ideas •

We are also trying to provide opportunities for Liaisons to share their colleges' plans for the Phase 1 funds. In addition, we are interested in documenting your ZTC professional development needs – what do you and your faculty need to achieve your ZTC goals? The Chancellor's Office has stated that each college should include in its ZTC plan specific reference to any professional development or training that is necessary to be successful. When doing so, we ask that you consider also including reference to the OERI as the preferred professional development provider. It will come as no surprise that the OERI is well-positioned to supply colleges with OER-related professional development. Additionally, we have the infrastructure necessary to convene discipline faculty to both identify areas of OER development as well as options for disciplines that are not able to use OER.

Greetings! As the Open Educational Resources Liaison for our college, it is my responsibility to share communications from the Academic Senate for California Community Colleges (ASCCC) Open Educational Resources Initiative (OERI). Please read on to learn about upcoming events and opportunities that are open to all. If I can assist you as you consider OER or answer any OER related questions, please let me know.

• Regional LibreTexts Workshops •

In partnership with LibreTexts, the ASCCC OERI is pleased to announce the Fall 2022 regional LibreTexts Workshops. The workshops will showcase the ADAPT and LibreStudio platforms - sponsored by the California Education Learning Lab - as free homework assessment platforms for all California instructors and students.

Throughout the workshop, we will demonstrate how instructors can use ADAPT to augment existing and newly constructed OER textbooks with summative exercises and embed them in Canvas and LibreTexts textbooks. Discussions will cover how the

[ADAPT homework system](#) empowers faculty to build and use existing questions in multiple modalities: (1) formative vs. summative, (2) autograded vs. open-ended grading, and (3) embedded in Canvas or textbooks. Participants will learn how to build autograded questions based on four technologies - H5P, WebWork, iMathAS, and native (QTI) - that can be used interchangeably to allow for maximal impact. We will introduce the [LibreStudio platform](#) for construction, storage and distribution of H5P assessments. Participants will be encouraged to join LibreStudio to create and share H5P assessments, review the H5P of other authors, and build a community within Studio.

Registration for the Southern California workshops is now open. These day-long workshops (9:00 am – 3:00 pm) are free.
