Greetings! The ASCCC Open Educational Resources Initiative (OERI) provides statewide professional development and funding opportunities to support the expansion of the adoption of Open Educational Resources (OER) in the California Community Colleges. “OER” refers to teaching and learning materials that are freely available online for everyone to use and includes course modules, lectures, homework assignments, lab and classroom activities, pedagogical materials, games, simulations, and many more resources contained in digital media collections from around the world (as defined by OER Commons). OER most often refers to openly-licensed textbooks and ancillary materials that are available at little or no cost to students. The OERI facilitates and coordinates the curation and development of OER texts, ancillaries, and support systems. In addition, the OERI supports local OER implementation efforts by offering professional development, technical support, and technical resources.

The monthly OERI Newsletter provides recipients with an update on the work of the OERI and a calendar of upcoming OERI sponsored events.

• ZTC Acceleration Grant Collaboration Cohort Updates •

As April concludes, all of the Collaboration Cohorts have met and many have met more than once. The initial convenings of each cohort began with an overview of the [Zero Textbook Cost \(ZTC\) Collaboration Cohort Process](#) document that participants were asked to review prior to the meeting. After a quick overview of the process, the information provided by the cohort colleges regarding their ZTC sections and plans was shared and observed trends were discussed. In addition, participants were asked to clarify or confirm their representatives and make corrections to the information the OERI shared regarding their existing ZTC sections and their ZTC needs.

The OERI is working with the cohort members to develop plans for the cohorts with a goal of completing the cohort process before the end of the current term. At the conclusion of the work of a cohort, the OERI will develop a final report that documents

the work of the cohort and, when appropriate, provides workplans for the participating colleges to facilitate their access to funding to complete their work. When a cohort's work is complete, this will be communicated to the California Community Colleges Chancellor's Office and the OERI will provide cohort members with guidance and the form needed to obtain additional funds. Please note that this process involves only those colleges who are participating in a cohort that has not received the funds they previously applied for (i.e., colleges who opted into the cohort process and received \$25,000 of an Acceleration Grant). These cohort members need to be prepared to report on how the \$25,000 was and/or will be spent and provide a budget for the funds they are now seeking (up to \$170,000). Any changes in the amount requested will need to be accounted for.

• Visualizing the Impact of ZTC/OER •

The OERI is please to share that it is working with Chabot College to develop a model for sharing the impact of your local ZTC and OER efforts on student success. Chabot's proposal for faculty and researchers to collaborate on this endeavor has been funded by 2024 OER Michelson Spark Grants. Below is an excerpt from the announcement about the award.

[Chabot College](#), in collaboration with the [Academic Senate for California Community Colleges Open Educational Resources Initiative](#) (OERI), is driving innovation through data-driven approaches to promote ZTC and OER adoption across the California Community Colleges. Through the development of a scalable dashboard model, Chabot is empowering institutions to make informed decisions and advocate for ongoing funding and policy support. With a focus on equity and collaboration, Chabot's initiative to track ZTC adoptions via this

dashboard will begin with a six campus pilot and has the potential to revolutionize OER efforts. If proven successful across multiple campuses, this model may be scaled statewide.
