Welcome to the Fall 2024 term and the 2024-2025 academic year. While there were no surprises over the summer, it was a busy one – and the year ahead looks to be as well. We're looking forward to catching up with you and learning about your OER-related needs and accomplishments.

Fall 2024 OER Liaison Kick-offs

The OERI supports Open Educational Resource Liaisons (OERLs) so that they may serve as advocates by taking an active role in increasing local OER awareness, adoption, and assistance. Each college's OERL will be eligible for a yearly stipend of \$1,000. OERLs who complete the specified activities for a given term (fall or spring) will receive \$500 after the term's end upon verification of their eligibility by the OERI. Colleges may appoint more than one OERL, with the duties and stipend divided in a manner deemed appropriate by the local senate. All appointments and exceptions must be confirmed by the local senate president. If you are no longer serving as the OER Liaison for your college, please let us know.

All OER Liaisons are required to attend a Fall 2024 OERL Kick-Off. Live sessions will be delivered via Zoom and you are encouraged to attend this option. XB12 Implementation •

Questions continue to persist about XB12, the section-level data element that is intended to capture information regarding textbook costs and how no-cost sections achieved their no-cost ("ZTC") status. Fortunately, most of the current questions seemed to be a consequence of not viewing the most recent revision of the data element. While efforts have been made to address these questions, on-going confusion is understandable as the data element is misnamed, the various versions of the XB12 definitions are not clearly identified, and a Google search to find the most current version is likely to yield the wrong version. If you are viewing the most recent revision of the XB12 data element definitions, you will see the following in the introduction:

The instructional material definition in Title 5 is more broadly defined; however, for the purpose of this data element, only the cost of course textbooks (including lab manuals) and supplementary materials (including software and homework systems) are to be reported.

And this final note at the end of the document:

Revision: Summer 2024 Added clarifying language distinguishing "course materials" from instructional materials as defined in Title 5
Removed "B - Section uses only no-cost digital instructional material"
Added E, F, G to better distinguish between different types of no-cost instructional materials and to add a category where the section may use a mix of no-cost OER and other course materials

These changes clarify that while the data element is titled "instructional-material-cost", its scope is limited to textbooks and supplemental materials. This clarification is important as it aligns what is being coded as no-cost with the definition of ZTC used in the context of the ZTC Degree Program and the recommended interpretation of California Education Code 66406.9 (often referred to as "SB 1359") that requires the California Community Colleges to "[c]learly highlight, by means that may include a symbol or logo in a conspicuous place on the online campus course schedule, the courses that exclusively use digital course materials that are free of charge to students and may have a low-cost option for print versions." The ASCCC's recommended interpretation of California Education Code 66406.9 encourages using the no-cost mark whenever a section has no textbook and supplemental material costs, regardless of how that no-cost status is achieved.

Fall 2024 Zero Textbook Cost (ZTC) Program – An Overview and Update

A year ago, colleges were determining how to use the funds they received from the Implementation Grant as well as rushing to identify ZTC pathways to apply for the Acceleration Grants that had recently been made available by the Chancellor's Office. Today, local ZTC leads are focused on ensuring that the ZTC pathways supported by Implementation Grant funds are available to students by the Fall 2025 deadline and that they meet the Fall 2026 deadline for pathways funded with Acceleration Grants. In addition to engaging in activities to facilitate ZTC pathway development, local ZTC leads are also asking questions about the reporting requirements associated with the receipt of funds and how new OER developed with ZTC funds will be shared. What information will be needed for the December 2024 ZTC reporting and expenditure progress reports? How will COOL4Ed be used to share resources? Join us to find out the latest on all of these topics – and to ask your questions.
