

# ASCCC OERI October 2024 OER Liaison Newsletter

It's hard to believe that fall is officially here – and nothing is slowing down in the ZTC and OER world. Since the first OERL kick-off, we've learned of a new version of the draft Title 5 regulation that we originally shared in our June newsletter, the OERI has identified several new discipline leads, and more of the Collaboration Cohorts have concluded their work. Read on for updates on everything, as well as an exciting Artificial Intelligence professional development opportunity, a wealth of webinars, an in-person OERI regional event, and an opportunity to attend Open Ed 2024 for free.

#### Fall 2024 OER Liaison Kick-offs

The OERI supports Open Educational Resource Liaisons (OERLs) so that they may serve as advocates by taking an active role in increasing local OER awareness, adoption, and assistance. Each college's OERL will be eligible for a yearly stipend of \$1,000. OERLs who complete the specified activities for a given term (fall or spring) will receive \$500 after the term's end upon verification of their eligibility by the OERI. Colleges may appoint more than one OERL, with the duties and stipend divided in a manner deemed appropriate by the local senate. All appointments and exceptions must be confirmed by the local senate president. If you are no longer serving as the OER Liaison for your college, please let us know.

All OER Liaisons are required to attend a Fall 2024 OERL Kick-Off. Live sessions will be delivered via Zoom, and you are encouraged to attend this option. # ADAPT Update

Despite events that threatened to end the free availability of the LibreTexts ADAPT homework system, ADAPT will continue to be free for California community colleges to use for the foreseeable future. The budget modifications that created the concern, however, prevent the development of new features without explicit support.

# ZTC Funds and Faculty Compensation

If you are involved in your local ZTC efforts and are unclear what funds your district has or has not received from the funding opportunities that were available last academic year, you can access the <u>2024-2025 Compendium of Allocations</u> to determine what funds have been disbursed.

Many local ZTC leads are still trying to determine what to pay faculty doing ZTC work, while others are navigating their local processes to ensure their faculty are paid. As with so much in our system, local practices vary – from districts where the union contract dictates compensation to those where no formal guidance exists. While our local circumstances vary, what we advocate for locally can be informed by what has been done elsewhere. # Draft Title 5 Language – Burden-Free Access to Instructional Materials – Take 2 •

At the September 23, 2024 Board of Governor's meeting, a new version of the draft <u>Title 5 §54221</u>. <u>Burden-Free Access to Instructional Materials</u> was considered. This version has an increased emphasis on OER, as compared to the original version, and makes it clear that the focus is not on ensuring student access to all instructional materials on the 1st day of class – but to those resources that students need.

The 45-day period for making comments has begun and comments on the draft regulation must be received by the Regulations Coordinator prior to 4:00 p.m. October 24, 2024. # New American Sign Language (ASL) Resource

The OERI is pleased to have the opportunity to share a recently developed resource in this newsletter. ASL faculty across the state have expressed interest in developing OER to establish ZTC ASL pathways. Melanie Nakaji, OER Liaison and ASL faculty at San Diego City College, is leading the development of a new video-based ASL curriculum and homework assignments in ADAPT that are presently being used in lieu of a textbook by ASL faculty at the college. The use of this curriculum to convert 12 classes to ZTC has resulted in a savings of over \$23,000 for students in just one term. Access the ASL resources developed by the SDCC team in ADAPT.

# Friday, October 4, 10:30 am - 11:30 am Course Cost Transparency in the California Community Colleges – The Past, The Present, and the Future

In 2010, a federal requirement that the costs of "college textbooks and supplemental materials" be made available to students at the time of registration took effect. This requirement was followed by regulatory changes that permitted California community colleges (CCCs) to require students to purchase access to electronic resources and then by a new state law that required the marking of course sections with no textbook costs. In 2024, our colleges are grappling with implementing a section-level data element (XB12) that captures course cost data, a new cost transparency law that takes effect on January 1, 2025, and a proposed new regulation that pushes colleges to ensure students have the instructional materials they need to fully participate on the 1st day of class. In this webinar, we will explore the history and interaction of these various requirements. Are there inconsistencies or contradictions? Or are the CCCs demonstrating how to truly make college affordable?
