### • ZTC Acceleration Grant Collaboration Cohort Update – The End is Near... •

The OERI will conclude the work of most of the Collaboration Cohorts by the end of October. As the work of a Cohort finishes, the OERI drafts a memo summarizing the results of the Cohort's efforts. This memo is then shared with the Cohort and the Chancellor's Office. During this phase, cohort members are given an opportunity to provide updates to their college's ZTC data and plans. Next, the OERI prepares a more comprehensive report that includes information on collaborative projects and the cohort members are afforded another opportunity to update their college information. As this newsletter is being drafted, we have just seven cohorts that are presently not yet able to conclude their work: Business, Chemistry, Communication Studies, Geography, Physics, Psychology, and Sociology. Many of these are among the larger of the cohorts, some of the pathways involve a large percentage of courses in other disciplines, and some have unique challenges to establishing ZTC status, such as homework systems or necessary printing costs. Please continue to check our website for updates and, of course, let us know if you have questions. If you are involved in your local ZTC efforts, please work with your colleagues to ensure prompt responses to our cohort-related messages.

### OER Transparency

The OERI has been working with the California Community Colleges Chancellor's Office to inform the process for sharing OER developed with ZTC funds in the COOL4Ed referratory. If you have not attended events that covered this specific aspect of the ZTC Degree Grant Program, you may not be aware that a stand-alone process is being developed for adding resources to COOL4Ed in order to be compliant with the ZTC legislation that requires that "[a]II open educational resources used as learning materials for a degree developed pursuant to this section shall be added to the California Digital Open Source Library established in Section 66408." Many faculty across the state have expressed interest in knowing what resources are being used, however it would not be productive for COOL4Ed to be overwhelmed with repeated reports of adoptions or minor adaptations of commonly used resources. As a result, the OERI is in the process of establishing a simple mechanism for any faculty member to report an OER adoption

so that we may gather adoption and minor adaptation data as a component of the ZTC reporting. At present, the ability to report OER text adoptions and minor adaptations is available for the resources in the following OERI curated collections:

### New OER – From Our Colleges and Beyond •

### Administration of Justice

<u>Criminal Law (Cartwright, 2024) (CC BY-NC-SA)</u> is an OER intended for use when teaching Concepts of Criminal Law (<u>C-ID AJ 120</u>). This textbook examines the most commonly committed crimes in California. Each chapter concludes with a list of key terms, a summary of the unit, and several review questions. Many chapters include a section titled IDEA FRAMEWORK. IDEA is an acronym which stands for Inclusivity, Diversity, Equity, and Anti-Racism and the chapter content was carefully selected to support concepts from the framework. This textbook was designed specifically for Madera Community College Criminology students.

### **Child Development**

Faculty at Coalinga and Palo Verde College collaborated to create a new resource for teaching courses focusing on child abuse and maltreatment through the Early Childhood Education and Child Development Collaboration Cohort.
