RE: 2025-28 Student Equity Plan

Background

The Student Equity and Achievement (SEA) Program was established in Education Code (EC) 78222 with the intent of supporting Guided Pathways and the system-wide goal of eliminating equity gaps. The SEA Program is an on-going categorical funding source for colleges. As a condition of receiving funds, per EC 78222, districts shall complete the following: maintain a student equity plan; provide matriculation services; adopt placement policies; provide support or establish on-campus food pantries or regular food distributions; and provide all students with an education plan.

2025-28 Student Equity Plan

The 2025-28 Student Equity Plan (SEP) is **now available in NOVA**, and college plans are due on **November 30, 2025.**

The Chancellor's Office convened a Student Equity Plan (SEP) Taskforce in 2024, from August to October, to review the 2022-25 SEP and provide recommendations for the 2025-28 SEP template. The recommendation themes included: ensuring continuity (especially for metrics and highlighting priority student populations), streamlining where possible, remaining race-conscious in plan development, engaging the entire campus (especially student *and* academic affairs), focusing on student education plan rates, dedicating a specific section to the executive summary, and providing as much time as possible for campuses to complete the plan.

The <u>2025-28 Student Equity Plan Planning Resources and Development Template</u> reflects the recommendations of the SEP Taskforce, and the template has also been aligned with Vision 2030— especially in providing: (1) opportunities for Vision 2030-aligned and related college goals to be included, and (2) questions that focus on Vision 2030 initiatives, practices, and populations. Other key updates to the 2025-28 SEP template include:

- Goals: Eliminate Disproportionate Impact (DI) and to Fully Close Equity Gaps.

 The 2025-28 SEP identifies and provides data for all Disproportionately Impacted (DI) student populations, as well as two goals: first, a baseline system and college goal of eliminating DI; and second, a goal of fully closing equity gaps in each of the student success metrics. Colleges will outline specific strategies for these two goals across all metrics. Colleges will also have the option to further disaggregate data to add additional student populations that are experiencing equity gaps.
- **Emphasis: Transfer.** The 2025-28 SEP asks colleges to examine and address the root causes as to why the majority of transfer-intending students do not transfer. Colleges will identify strategies to increase transfer with equity, including removing barriers, addressing student needs, and creating clear pathways.
- Intensive Focus: Student Centered Plan. The 2025-28 SEP utilizes the same success metrics as the current 2022-25 SEP and provides continuity with the 2022-25 SEP for colleges to identify student population(s) needing intensive support. Colleges will craft a holistic plan across academic and student affairs to achieve equity for their "intensive focus" student population(s).
- **Spotlight: Comprehensive Student Educational Planning.** The 2025-28 SEP includes a section on student educational planning, focused on monitoring and increasing equitable comprehensive educational planning in alignment with SEA regulations.
 - Per EC <u>78222</u>, as a condition of the receipt of SEA Program funds, districts shall "provide all students with an education plan that identifies courses, a sequence of courses, key progress milestones, and other requirements the student must complete to earn an associate degree, career technical education certificate, other community college certificate, or meet transfer requirements. Notwithstanding any other law, students who are exempted from having an education plan under Section 78215 are not subject to the requirement of this paragraph." Please refer <u>Title 5 CCR 55524</u> for more details and guidance on student education plans.
- **Clarity: Executive Summary.** The 2025-28 SEP provides more clarity and emphasis on the SEP Executive Summary and active campus involvement in developing SEP.
