#### 2024 - 2025 Exemplary Program Award Winners

Coalinga College and Diablo Valley College were the recipients of the 2024-2025 Exemplary Program Award, which honors community college programs demonstrating innovation and excellence. Lemoore College and MiraCosta College earned this year's honorable mentions.

This year's theme, 'Integrating, Advancing, and Sustaining Open Educational Resources for Access and Equity,' recognized programs that addressed the challenges, experiences, and perspectives of students, focusing on ethnic studies courses that enable them to explore their own narratives.

#### ZTC 2025 Allocation •

On December 19, 2024 the California Community Colleges Chancellor's Office (CCCCO) distributed ZTC 2025 Allocation (ESLEI 24-71). This memo indicated that each of the system's degree-granting colleges would receive \$320,000 via apportionment in early 2025 with the expectation that these funds would be used to establish two ZTC pathways. It also indicated that funds would be allocated to the OERI to support this work. A follow-up communication on January 13, 2025 shared that "The Chancellor's Office is also in the process of designing and releasing an RFP to provide a robust, statewide OER platform for system use – a necessary next step in supporting a statewide OER infrastructure as recommended by the Burden Free Instructional Materials Task Force." This communication also explicitly stated that the additional funds could be used to support the development of pathways that had not previously been fully funded. The OERI continues to archive the ZTC-related communications distributed on the ZTC listsery at CCCCO ZTC Listsery Communications. Additional information about the ZTC 2025 allocation will be shared at a webinar on January 29.

#### ZTC Program Support and Sustainability

As the OERI prepares to actively support local ZTC efforts, we are scheduling professional development opportunities intended to assist the local launching of OER development efforts – from increasing the availability of support for faculty preparing to develop OER to identifying ways to address local project management needs. The input of OER Liaisons and ZTC leads will inform our efforts. We will be creating opportunities for you to share your thoughts, ideas, and questions in the scheduled OERL Kickoffs and other venues in the months ahead.

The OERI has long recognized the need to provide a means to ensure the sustainability of the OER it has supported the development of and is also committed to establishing a process to facilitate the update of commonly used OER more generally. What's the best way to track developments that need to be incorporated into course materials – and how do we facilitate the integration of necessary changes into existing OER? As approaches by discipline are likely to vary, determining how to proceed will require the engagement of discipline faculty. We anticipate piloting approaches with a few disciplines that can then be modified to meet the needs of others.

#### OER Adoption Data Collection Efforts

We need your help! The OERI has established a simple mechanism for any faculty member to report an OER adoption so that we may gather adoption and minor adaptation data as a component of the ZTC reporting. To report the adoption of a specific resource, please navigate to the <u>relevant discipline collection</u> or search for the resource in our <u>OER by C-ID table</u>. Each textbook equivalent will have a button that leads to a brief form.

Please share this information widely to help us in our data collection efforts.

## • Facilitator-Supported Open Educational Resources (OER) Basics Course •

The ASCCC OERI is pleased to offer a facilitator-supported version of our OER Basics course. Participants in the ASCCC OERI's facilitator-supported OER Basics course will learn about Creative Commons licensing, evaluating OER, curating and creating OER, and designing accessible materials aligned with Universal Design for Learning (UDL) principles and Open Educational Practices (OEP). Weekly office hours on Thursdays and Fridays will support participants as they progress through the course and earn their completion badge. It is estimated that course completion will take approximately 20 hours.

Facilitator support will be provided from February 10, 2025 until March 14, 2025. During the course, participants are encouraged to attend the weekly office hours, held twice weekly beginning Thursday, February 13, and ending on Friday, March 14. Office hours for each week will correspond to the modules in the course:

- 1. OER: Definition and equity implications
- 2. Creative Commons licenses and copyright: How content can be used and attributed
- 3. Finding OER: Search strategies and repositories
- 4. Curating, adapting, and creating OER: Combining resources with different licenses and platforms for creating customized resources
- UDL and OEP: Creating accessible resources that engage students and promote learning
