• Determining Faculty Interest in OER Development •

The Academic Senate for California Community Colleges (ASCCC) Open Educational Resources Initiative (OERI) anticipates recruiting faculty to participate in the development of OER for courses that lack critical resources. The target courses and the specific resources to be developed will be determined following an analysis of data from the Collaboration Cohorts, information from colleges regarding the use of [ZTC 2025 Allocation](#) funds, and demonstrated faculty interest. Currently, the OERI has developed a list of courses that appear to lack OER. These courses, which appear on the [OERI-Identified Priority Courses](#) list, are likely candidates for the proposed OER development.

In order to determine faculty interest in this work, we are inviting all faculty to demonstrate that interest by completing the [ASCCC OERI Application](#) and selecting “Potential OER Development Opportunity” as the role they would like to be considered for on the application. When discussing your OER experience in the application, please note any OER basics and/or licensing training you have received. If you presently do not have such experience, you are encouraged to consider completing the OERI’s self-paced [ASCCC OERI – OER Basics](#) and [ASCCC OERI – Accessibility Basics](#) courses or any comparable opportunity that provides an overview of discovering OER, remixing OER, Creative Commons licensing, and accessibility. Faculty with this necessary foundational knowledge will be prioritized when participants are selected. Please identify the courses you are interested in working on by responding to the final two questions in the application, either selecting from the list provided or specifying other courses in response to the final question.

Any survey of dance studies should begin with the question: What is dance? Dance is more than movement. "Dance is a transient mode of expression, performed in a given form and style by the human body moving in space. Dance occurs through purposefully selected and controlled rhythmic movements; the resulting phenomenon is recognized as dance by both the performer and the

observing members of a given group” (Keali’inohomoku, 1983). This book will survey many dance forms from around the world.
