

ASCCC OERI October 2025 OER Liaison Newsletter

As we transition from September to October, we are entering two new phases of the ZTC Degree Program: colleges will soon be able to add their newly developed OER to COOL4Ed and the selection of an OER platform for the system is expected to be announced in early October. On September 22, there was a webinar that showcased the new interface for uploading resources to COOL4Ed. Some of the questions and concerns that arose during the webinar are summarized in this newsletter. As always, we look forward to seeing you at one of October's many events.

Fall 2025 OER Liaison Expectations and Tracking

The OERI supports OERLs so that they may serve as advocates by taking an active role in increasing local OER awareness, adoption, and support. OERLs are faculty who are appointed by their local academic senate. Each college's OERL will be eligible for a yearly stipend of \$1,200. OERLs who complete the specified activities for a given term (fall or spring) will receive \$600 after the term's end upon verification of their completed work. Local senates may appoint more than one OERL, with the duties and stipend divided in a manner deemed appropriate by the senate. All appointments and exceptions must be verified by the local senate president. Your local senate president should direct any OERL updates to the OERI's general email (oeri@asccc.org).

All OERLs are required to either attend a Fall 2025 Kick-Off or view the Fall 2025 Kick-Off recording prior to attending an OERL Fall 2025 Goal-Setting meeting. All OERLs will need to attend an OERL Fall 2025 Goal-Setting meeting by October 10 and identify their goals for the term by October 17. ASCCC Fall 2025 Plenary and OERI Resolutions

The ASCCC's Annual Fall Plenary Session will be held November 6–8, 2025 in La Jolla. The Pre-Area Meeting Resolutions Packet is scheduled to be distributed to field on September 26, 2025. An OERI resolution that is included in the packet relates to the new title 5 regulation 5, §54221 Burden-Free Access to Instructional Materials and asserts that the intent of the regulation is not merely first-day access, but first-day nocost access. OERI does anticipate bringing additional resolutions to Area Meetings. If you have an idea for a resolution, please let the OERI know. Interesting in attending an Area Meeting? COOL4Ed and You

Even if you are not directly involved in your college's ZTC efforts, it is likely that you have some connection to the OER work that faculty at your college are doing. Below you will find questions, answers, and information related to some of the issues that were raised at a webinar on using COOL4Ed on September 22, 2025. New OER are not being added to the existing COOL4Ed collection, instead a new interface has been developed for the purpose of gathering the products associated with the current ZTC program. It is expected that access instructions will be sent to each college's designated email and the new ZTC COOL4Ed site will be available on September 24.

Why is there a requirement that OER developed with ZTC funds be licensed CC BY?

Although the ASCCC has sought to change this requirement, specifically advocating for allowing CC BY-NC, the requirement is codified in the Procedures and Standards of the Board of Governors and efforts to change it were not successful. The document requires that "Any published materials produced under an agreement or sub-agreement using public funds must be subject to a Creative Commons Attribution License (CC BY)" (Procedures and Standards of the Board of Governors, December 2022 Edition, p. 40). The ASCCC was successful in advocating for the clarification that CC BY should not be used when it conflicts with other licenses in a resource. In other words, if you are creating a derivative of a work with a different license, such as CC BY-NC or CC BY-NC-SA, applying the CC BY license to your

derivative would not be permissible. While the Board of Governors requires that work produced with ZTC funds must be licensed CC BY, that license may not be imposed on the work of another if it is not compatible. Why is C-ID referenced in the course data submitted to COOL4Ed and not Common Course Numbering (CCN)?

CCN is a new requirement for the California Community Colleges curriculum that is expanding and changing regularly as new CCN templates are developed. In contrast, C-ID is well-established and stable. COOL4Ed is not intended to be updated on a regular basis. However, CCN can – and should – be included as a resource tag. This information will be particularly useful when the course being supported with OER is one that has a CCN but does not have a C-ID.

Why is there a separate process for sharing minor modifications of existing OER? And how do we determine when to use this process?

To ensure the usefulness of COOL4Ed, minor modifications of existing OER (adaptations and remixes) should generally not be added to COOL4Ed. A resource should be added to COOL4Ed when 30-50% of the content (by volume or pedagogical impact) is new, restructured, or substantially changed. This is a guideline and subject to local interpretation. OER that are adapted or remixed with minor changes can be reported to the OERI with an overview of the changes made instead of being added to COOL4Ed. Such resources will be made available by the OERI and the OERI will report this information to the California Community Colleges Chancellor's Office. Access the OER Project Update Submission Form to report your ZTC-funded adapted and remixed OER. This is an optional alternative to adding resources to COOL4Ed that you can use if appropriate. If a bulk upload process is desired and/or you are uncertain as to whether to include your OER in COOL4Ed via the process referenced here, please contact the OERI for assistance (oeri@asccc.org). Additional guidance is forthcoming. The information fields specified for submission to COOL4Ed will suffice for submission to OERI. Sharing a modified OER with the OERI will fulfill the reporting requirement for these resources.

ASCCC AI Events and Resources

NEW! The OERI is pleased to share Artificial Intelligence (AI) Attribution and Citations for Open Educational Resources (OER) Frequently Asked Questions (FAQ). This resource was developed by Liz Encarnacion, the ASCCC OERI Artificial Intelligence Lead and is licensed CC-BY-NC-SA 4.0. It provides guidance on the proper attribution and citation of AI-generated content for OER authors, content creators, remixers, and users. While the FAQ is a "living document," meant to be updated as the usage and understanding of generative AI continues to advance, it currently addresses various scenarios, including suggestions on how to cite AI-generated images and text, provides clarification on copyright implications for AI-created works as per the U.S. Copyright Office, offers advice on managing inaccuracies, and emphasizes the importance of transparency and responsible integration of AI in academic and creative endeavors.
